ÁREAS S.A.U., with national Tax ID A-08.225.013, and registered offices in Barcelona (08014), Av. Diagonal, N 579-585, 5º piso, have organized a special offer which will be regulated in accordance with the following,

TERMS AND CONDITIONS

1.- PURPOSE: The purpose of this action is to promote the products and stores of **ÁREAS S.A.U.**

The surveys entered in a draw will not be included in later draws.
